事件:公司发布 2022 年报,22 年实现收入 22.36 亿元(同比+17.50%),归母净利润 3.61 亿元(同比+22.69%),扣非归母净利润 2.84亿元(同比+23.29%),毛利率 56.64%(同比+2.00pp)。22Q4 收入 7.87 亿元(同比+24.10%),归母净利润 1.40 亿元(同比+19.99%),毛利率 51.51%(基本持平)。

地理空间/公共事业产品快速推广,海外持续高增。分业务来看, 建筑与基建板块收入 9.17 亿元 (同比+6.68%), 毛利率 61.75% (同比+0.80pp), 22 年公司推出"视觉 RTK"高精度接收机智能装 备、"TCF900桩基施工质量管理系统"等,相应产品市占率、应用持 续拓展; 地理空间信息板块收入 4.22 亿元 (同比+22.23%), 毛利 率 45.97% (同比-8.52pp), 22 年公司针对该业务推出自主研发的 新一代长距高精度激光雷达 AU20, 已取得较好推广效果, 公司还 发布全新智能测绘无人船"华微 3 号 Pro", 实现智能水域测绘; 资 源与公共事业板块收入 7.98 亿元 (同比+31.07%), 毛利率 57.83% (同比+11.78pp), 22年公司农机自动驾驶产品实现快速推广, 巩 固市场优势地位,公司表面位移检测系统等产品入选 22 年水利系 统重点采购目录; 机器人与自动驾驶板块收入 0.99 亿元 (同比 +10.84%), 毛利率 45.24%(同比-7.75pp), 公司 22 年已成为多 家车企自动驾驶位置单元业务定点供应商,并实现批量交付,未来 预计持续产生订单。分产品、高精度定位装备收入 10.93 亿元(同 比-0.06%),系统应用及解决方案收入 11.43 亿元(同比 +41.22%)。海外市场拓展迅速,收入 4.87 亿元(同比 +54.56%).

持续加码研发,股权激励逐步施行。费用方面,2022 年公司销售、管理、财务费用率分别为19.97%(同比-2.14pp)、8.25%(同比+2.16pp)、-0.65%(同比-1.18pp),管理费用同比变动较大系股权激励摊销、上海武汉两地华测时空智能科创产业园投入使用的折旧摊销增加等,研发费用4.03亿元(同比+21.11%),研发费用率18.02%(同比+0.54pp)。公司22年因实施股权激励计划产生费用约4133万元。

盈利预测与投资建议。未来随着下游需求复苏,公司继续紧抓高精度定位智能化市场拓展机会,同时,乘用车自动驾驶产品步入规模化量产阶段,带来又一增长引擎,长期发展可期。我们预计公司23-25 年 营 收 为 29.80 亿 元 (-14.22%)、38.59 亿 元 (-14.76%)、49.05 亿元,归母净利润为 4.74 亿元 (-9.71%)、6.16亿元 (-9.94%)、7.86亿元。参考可比公司估值,给予2023年PE为45x(-18.18%),对应目标价格为39.84元(-0.75%),维持"优于大市"评级。

风险提示。海外市场拓展不及预期;国内市场新兴业务拓展低于 预期。

Summary

Event: The company released 2022 annual report, 2022 achieved revenue of Rmb2.236bn (+17.50% YoY), NP was Rmb361mn (+22.69% YoY), recurring NP was Rmb284mn (+23.29% YoY), gross margin 56.64% (+2.00pp YoY). 22Q4 revenue was Rmb787mn (+24.10% YoY), NP was Rmb140mn (+19.99% YoY), gross margin was 51.51% (basically flat).

Rapid promotion of geospatial/utility products and continued high growth overseas.

Continuously increase R&D and gradually implement equity incentives.

We estimate the company's 23-25 revenue to be Rmb2.980bn (-14.22%), Rmb3.859bn (-14.76%) and Rmb4.905bn, and NP to be Rmb474mn (-9.71%), Rmb616mn (-9.94%) and Rmb786mn. With reference to the valuation of comparable companies, the PE for 2023 is 45x (-18.18%), corresponding to a target price of Rmb39.84 (-0.75%), maintaining an "Outperform" rating.

Risks: overseas market expansion is not as expected; emerging business expansion in domestic market is lower than expected.




